



Teepee & Lace Wigwam Terms & Conditions

General

The 'Hirer' means the person signing the booking form for 'Hire of equipment'.

1. Provisional bookings for events shall be held for 48 hours. Event dates not confirmed and deposit paid will be re-released.
2. Payment of a £75 deposit is acceptance of these terms and conditions and is considered a binding contract.
3. The deposit will be deducted from the final balance and the remaining balance is due 14 days before the party date along with a security deposit of £75.
4. The security deposit will be refunded within 48 hours after the event following inspection of equipment and accessories.
5. It is the responsibility of the Hirer to provide the correct bank details to Teepee N Sleeppez to ensure that the security deposit can be refunded back to the Hirer without delay.
6. Our hire prices include delivery within 10 miles from our base in Aldershot, Surrey.
7. Out of area bookings can be arranged at an additional delivery cost of £1.00 a mile, there and back on each journey. Some addresses in London will incur an additional delivery charge due to the congestion charge.
8. The final numbers and choices must be confirmed at least 14 days prior to the date of the booking. Any booking reductions after this time will still be charged for at the previous rate, with no refunds due.
9. The Hirer is responsible for providing Teepee N Sleeppez with all relevant medical/dietary information for all persons attending the party. Teepee N Sleeppez take no responsibility for allergies (including skin, food, materials etc) where we are not advised in advance of the condition. We are likewise not responsible at any point, for the welfare of the children at the parties, which remains the full responsibility of the hirer.
10. The Hirer is responsible for ensuring the accuracy of the information given to Teepee N Sleeppez and to pass over such information in sufficient time for Teepee N Sleeppez to perform the contract safely and without risk, within 14 days of the event occurring, to avoid last minute disappointment
11. Teepee N Sleeppez reserves the right to make any changes to the services as is deemed necessary without notice to the Hirer. If the required service is less than originally requested the requisite refunds will be made to the Hirer.
12. The Hirer is responsible/ liable for any damage or injury occurring from or as a result of inappropriate use or misuse or reckless use of any of Teepee N Sleeppez equipment.



13. It is the Hirers responsibility to ensure that the children are supervised at all times. Teepee N Sleeppez will charge the hirer for the costs of any damage to any property caused by your breach of this clause.
14. It is the Hirers responsibilities to ensure all persons comply with all reasonable instructions from Teepee N Sleeppez to ensure the safety of the attendees and other persons present. Teepee N Sleeppez may suspend the event if you are in breach of this clause.
15. Teepee N Sleeppez will accept no liability or responsibility to the Hirer for any damages, costs, losses, claims, expenses, demands and proceedings including property of Hirer and their guests, or any consequential loss in these regards.
16. Teepee N Sleeppez shall use all reasonable endeavors to provide the services in accordance with the contract and shall perform the services with reasonable skill, care and diligence.
17. It is not the intention of Teepee N Sleeppez to violate any copyright laws and all themes are only inspired by popular trends.
18. Teepee N Sleeppez will do everything possible to ensure set up and collection is at the agreed time however delays may occur due to severe traffic problems, road closures or accidents.
19. All prices are subject to change however prices quoted at the time of booking will be honoured.
20. The Standard sleepover package includes free delivery (within a 10-mile radius of Aldershot), assembly, styling and collection of equipment the following day. Delivery outside of this radius will be charged at £1.00 per mile. London congestion charge and off-street parking fees will also be charged if incurred.
21. The Basic sleepover package includes free delivery (within a 10 -mile radius of Aldershot) and collection of equipment the following day. Assembly and styling of the equipment is the responsibility of the hirer. Delivery outside of this radius will be charged at £1.00 per mile. London congestion charge and off- street parking fees will also be charged if incurred.
22. The hire period is 1 night however extra nights can be arranged with prior agreement with Teepee N Sleeppez.
23. The equipment must not be used outdoors

Company Responsibilities

1. Teepee N Sleeppez will deliver, erect and furnish your Teepees or Wigwams as per the agreed booking arrangements on the date specified and will return to dismantle and remove on the agreed end day of hire period.



2. Teepee N Sleeppez accepts no responsibility or liability for damage or theft to any property left in our tents for the duration of the hire period.
3. Teepee N Sleeppez accept no responsibility or liability for damage or injury to any member of your party may occur during the hire period.

Hirer Responsibilities

1. The hirer is responsible for ensuring adequate indoor space. The space required per teepee and mattress is approximately 110cm x 185cm minimum and the breakfast trays are an additional 56cm x 36cm wide. These can either go at the foot of the bed or on the bed itself if space is limited. The space required is to ensure safety of the children moving in and around the area. The space required per lace Wigwam and bed is 120cm x 185cm.
2. The Hirer must ensure that the area be free of furniture prior to our arrival and is clean (dirt and dust free) and is ready for the party to be set up and styled. Teepee N Sleeppez are not responsible for the removal of furniture to enable the party to be set up. Any delay in the start time because of this may result in a waiting fee being charged.
3. Teepee N Sleeppez will not refund any monies paid in the event that adequate space is not available for set up.
4. We regret that our equipment is not suitable for animals of any kind.
5. Smoking is strictly prohibited in or close to any of Teepee N Sleeppez equipment.
6. All rubbish, recycling and personal property must be removed from our tents prior to collection. Teepee N Sleeppez reserves the right to levy a charge for the removal of any rubbish or waste left in the tent. This levy will be charged from the damage deposit.

Payment

1. A £75 non-refundable deposit is payable on booking to secure your date. Party date will be held for 48 hours. Party dates not confirmed within these times will be re-released. We require an additional £75 which will act as a damage deposit. This will be refunded after inspection usually within 48 hours after collection of equipment.
2. The balance of hire is due 14 days prior to your booking date, if you book your event within 2 weeks the full balance is due at time of booking.
3. Payment is to be made via transfer (Bank details can be found on Hirers invoice)



Cancellation (By the Hirer)

1. Cancellation of a booking up to 14 days prior to the event will forfeit the deposit paid.
2. Cancellation of a booking within 14 days prior to the event date will forfeit all monies paid.
3. It is at the discretion of Teepee N Sleeppez as to whether the event may be rescheduled to a later date.

Cancellation (By Teepee N Sleeppez)

2. Damage to Equipment

1. If any of Teepee N Sleeppez items for hire, including tents, furniture, fittings or decorations are damaged or missing you will incur additional charges. This payment will be taken from your damage deposit in part of full.
2. If the cost to replace the damaged or missing items exceeds the value of the security deposit an additional invoice will be issued for immediate payment.
3. To avoid accidents, we ask that food and drink are not to be consumed inside the teepee's and any nail varnish that may have been applied is completely dry. If children are wearing any sort of makeup, we would ask that this be removed before getting into bed.
4. Smoking is strictly prohibited in and around the teepee's and equipment as this creates a fire hazard and to prevent smoke odour on the equipment. If found then the equipment will all need to be professionally cleaned and will result in loss of security deposit and potentially incur extra charges.

4. Out of area bookings can be arranged at an additional delivery cost of 85p mile, there and back on each journey. Some addresses in London will incur an additional delivery charge due to the congestion charge.
5. The final numbers and choices must be confirmed at least 14 days prior to the date of the booking. Any booking reductions after this time will still be charged for at the previous rate, with no refunds due.
6. The Hirer is responsible for providing Teepee N Sleeppez with all relevant medical/dietary information for all persons attending the party. Teepee N Sleeppez take no responsibility for allergies (including skin, food, materials etc) where we are not advised in advance of the condition.
